Welcome and Introductions: Corey Joyce had the committee introduce themselves and give the entity they represented, as well as the guests.

Pubic Comment Period: Both John and Jack deferred to comment at this time other to say that Jack Darnton is the president of O.A.R.S. and is promoting John Guinn to replace Robin Pestarino as the Under 40 Feet Recreational Boats and OARS' representative to the MAC.

Regular Agenda:

- 1. Approval of the Minutes from October 20, 2016 were approved after revision. There was not a quorum at the December 13, 2016 meeting to approve them.
- 2. Marina Happenings Brad Johnson
 - Maintenance in North Basin security lighting at ASBC boat yard has been completed
 - dredging of M-N-O Docks completed. Now the whaler boards and through rods need to be replaced
 - January 27 February 4 will be the Seattle Boat Show and many staff members will be attending. The Anacortes Boat Show is scheduled for April 6 9, 2017
 - credit card pay points at the North Basin facilities are being connected
 - new keyless entry to North Basin laundry and bathrooms are being installed now
 - Army Corp of Engineers, POA and the Port of Skagit have been looking at our breakwater to determine if it has a failing grade, a report will be sent as to what will need to be done
 - the Corp has the responsibility for A F Docks as A Dock is a federal waterway

New Business:

- 3. Greg Mustari referred to an item from the 12/13/16 meeting in which a customer of one of the boat brokers was unhappy with the service he received from the broker and then the POA. Dan reported that he and Bill Short took care of the problem from the Port's perspective. Mary said the customer was planning on attending the next Commissioners' meeting.
- 4. The frequency of the meetings (monthly, bi-monthly, quarterly) was tabled until next meeting in March.
- 5. Dan will have the membership list cleaned up with new MAC members listed.
