In accordance with RCW 39.04.155 and RCW 53.08.120, the Port may procure work under this procedure for which the estimated costs are \$350,000 or less. All Contracts for work exceeding this amount must be let by calling for sealed bids.

The Port's updated Small Works Roster shall be in effect through June 30, 2024.

All Contractors and Subcontractors must comply with the **“Washington State Prevailing Wages Law”** and submit the necessary Washington State Department of Labor and Industries forms for each contracted project with the Port of Anacortes.

All Contractors, when contracted for work with the Port of Anacortes, must provide evidence of commercial general liability insurance coverage with policy limits for bodily injury (including death) and/or property damage of not less than **\$1,000,000 per occurrence and not less than \$2,000,000 general aggregate**. If licensed vehicles will be used in performance of the Work, Contractor must also provide evidence of automobile liability insurance covering all owned, rented, and non-owned vehicles operated by Contractor with **\$1,000,000 combined single limit for bodily injury and/or property damage per occurrence**. Contractor’s policies shall name the Port of Anacortes as an additional insured by way of a policy endorsement.

Any Contractor, Subcontractor, or Sub-subcontractor which performs work under contract with the Port of Anacortes must provide evidence to the Port that states workers are covered by **“Longshoremens and Harbor Workers Insurance”**, only if workers are performing work over, in, or under the water.
